Position: Audio Supervisor

SUMMARY:

The Mark Morris Dance Group is seeking an Audio Supervisor to work with the technical production team of a modern dance company that performs almost exclusively to live music. The Dance Group does not tour with audio equipment other than its own microphones.

This is a freelance contract for 8 to 9 weeks of intermittent touring gigs in March through mid-June in the United States. This is a non-union job.

Responsibilities include but are not limited to:

- Will work directly under the Technical Director.
- Will be responsible for supervising and assisting local venue crews in setting up all required sound equipment, running sound checks and mixing all live and pre-recorded sound during the dance group's rehearsals and performances.
- Will be responsible for all advance audio planning and preparation between MMDG and the sound departments at various venues.

QUALIFICATIONS:

- Excellent audio-technical skills and a thorough knowledge of sound processing and the equipment involved
- Thorough knowledge of and experience with microphone placement
- Thorough knowledge of microphone placement for the live enhancement of voices and predominantly acoustical / non-electronic instruments.
- Experience with the mixing of live and pre-recorded music with an emphasis on classical, acoustical and non-electronic instruments
- Excellent communication and interpersonal skills to work with a demanding artistic team
- Experience working in a theatrical environment in the Performing Arts sector
- Prior touring experience
- Currently authorized to work in the United States
- Must hold a valid US driver license
- Must be fully vaccinated (including booster) against COVID-19 and strictly adhere to the <u>MMDG</u> <u>COVID-19 Safety Plan and Vaccination Policy</u>

Founded in 1980, the Dance Group performs the repertory of choreographer Mark Morris, hailed as the "the most successful and influential choreographer alive, and indisputably the most musical" (The New York Times), whose work is acclaimed for its ingenuity, musicality, wit, and humanity. Live music and community engagement are vital components of the Dance Group. It has toured with its own musicians, the MMDG Music Ensemble, since 1996, and regularly collaborates with orchestras and opera companies around the world. In addition to 16 full-time dancers, the organization currently employs 34 full-time staff and 75 part-time staff, teaching artists, and musicians.

In the heart of the Brooklyn Cultural District, the Mark Morris Dance Center, founded in 2001, is the hub of dance and music education in Brooklyn. The nine-studio building provides affordable classes in multiple genres for people of all ages, levels, with and without disabilities, accompanied by live music.
